**TO BE ADMITTED & PURCHASE TICKETS!**

Proper behavior is expected at all times of all attendees.  
All students must abide by the following regulations:

1. Lincoln students must be in good standing with their center and Lincoln High School to be eligible to purchase tickets for the dance. A list of students who are not in good standing will be given to the financial office by each center administrator, and those students **will not** be allowed to purchase a ticket.
2. Each dance form is verified for accuracy. In the event of any forged information or signature, the student will be denied admission to the dance and face disciplinary action.
3. Middle/Junior High school students, regardless of age, and guests over 21 years of age are not permitted to attend any dance.
4. No admittance to the dance after 8:30 PM. No dismissal from the dance before 10:30 PM.
5. All attendees (**Lincoln Students**) must show a school I.D. to purchase tickets and be admitted to the dance. Guests may have any form of a valid picture I.D.
6. The following are specifically prohibited at school-sponsored events: drugs, alcohol or sexually explicit dancing (**ex. freaking, grinding or dirty dancing**) and any dancing, which may result in disruption or injury (**ex. slamming, moshing, etc.**)
7. All school rules apply at school-sponsored events for both students and guests. Canes will not be allowed into the dance. Violations may result in disciplinary action and/or removal from the dance.
8. All students, guests, bags, backpacks and purses are subject to search upon entry to the dance.
9. Students suspected of being under the influence of drugs and/or alcohol may be subjected to an evaluation (breathalyzer test, etc...)
10. Any suspendable action will result in the loss of privileges and **WILL** prevent students from being able to participate in other extracurricular activities.
11. **Students are expected to follow the school dress code for this event, or will not be allowed in.**

Parents will be contacted to escort the student home. If parents are unable or unwilling to escort their student home, the student will be turned over to the custody of the San Diego Police Department.

Any major disruption will result in a five-day school suspension, and may result in that student being excluded from all school events for the remainder of the year. This will affect seniors and their participation in senior activities including GRADUATION.
